



PRESENT LIMITS OF THE TOWN OF SAGINAW.


ARTICLE 1: Since the Village of Saginaw has been previously incorporated and

not now in public use be declared non-existent.




BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF SAGINAW, MISSOURI, AS FOLLOWS:

SECTION 1. That there is hereby levied against all the taxable real estate, personal property and merchant ad valorem assessments within the corporate limits of the Town of Saginaw, Missouri, the sum of Fifty Cents upon each One Hundred Dollars assessed valuation for the General Revenue Fund of the Town of Saginaw, Missouri.


SECTION 2. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.


